## JV to yield stronger earnings

- · Long term industry demand remains intact
- Strong utilisation of new operational facility from the recent JV
- Better margins outlook from MITI 2-year moratorium and potential demand recovery from China
- Technically, HIAPTEK last closed at RM0.48. Monitor for a breakout, targeting RM0.51-0.525, with a LT target at RM0.535. Support is located around RM0.455-0.46, while cut loss is at RM0.45.

# Trading Catalyst

- Long term industry demand remains intact. Long term government initiatives such
  as the NETR and NIMP2030, coupled with the rollout of mega infrastructure projects
  and private construction activities are expected to augur well for domestic steel
  demand.
- Strong utilisation of new operational facility from the recent JV. In 3Q24, HIAPTEK achieved 90% utilization rate on its new 2.0MT blast furnace capacity and had completed other auxiliary facilities. The JV with ESSB is expected to provide significant revenue growth and better economies of scale in the coming quarters.
- Better margins outlook from MITI 2-year moratorium and potential demand recovery from China. MITI's 2-year moratorium on steel investments and the demand for steel products may be bottoming out with the Chinese government potentially rescuing the ongoing property crisis.

### **Technical Outlook**

• Share price has been consolidating around and last close at RM0.48. As the technical readings are positive, we expect follow-through buying interest with a flag breakout to be seen in the near term, targeting RM0.51-0.525, with a LT target at RM0.535. Support is set around RM0.455-0.46, with a cut loss set around RM0.45.
